

YMCA 'BSC LTS Outdoor Pools' PROMOTION - TERMS AND CONDITIONS (Terms)

1. OFFER AND ELIGIBILITY

- a. This 'BSC LTS Outdoor Pools' (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- b. By participating in the Promotion, you agree to be bound by these Terms.
- c. The Promotion is available at Boroondara Sports Complex (**Participating Centre**) between the dates of 7 September to 11 October 2026 (**Promotion Period**).
- d. To be eligible for the Promotion:
 1. You must not be a current swimming lessons member at the relevant Participating Centre or another Boroondara Leisure and Aquatic Facility;
 2. You must become a swimming lessons member at that Participating Centre within the Promotion Period.
- e. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.
- f. Membership offers, unit limits and promotion dates:
 - i. **4 weeks free** – 20 units (7 September – 13 September)
 - ii. **2 weeks free** – 50 units (14 September – 27 September)
 - iii. **1 week free** – 50 units (28 September – 11 October)
- g. Membership commitment terms apply as per the sign-up terms below.
- h. Promotion valid for promotion dates above, unless unit limit is exhausted prior.

2. SIGN UP TERMS

- a. Participants are eligible for free swimming lessons when sign up occurs in the Promotional Period. A credit will be applied to your account prior to the first debit once you have signed up.
- b. Membership offers i (4 weeks free) and ii (2 weeks free) only available with a minimum commitment term of 22 weeks.
- c. Membership offer iii (1 week free) is only available with a minimum commitment term of eight weeks.
- d. This Promotion is not applicable to existing swimming lesson members.

- e. The Promotion is only available at Participating Centres.
- f. The Promotion is available for Y swimming lessons not for school groups or holiday programs. It is available for infants, pre-school, primary school aged programs and teens etc (exclude schools and school holiday programs).

3. PRIVACY

4. MISCELLANEOUS

- a. YMCA reserves the right to amend, cease, extend and / or revoke the Promotion prior to the end of the Promotion Period in its sole discretion and without notice.
- b. To the extent permitted by law, YMCA will not be liable to any person for any cost, loss, damage, liability, expense or claim arising, whether directly or indirectly, in connection with the Promotion.
- c. Any dispute or situation not covered by these terms, will be resolved by YMCA management in a manner it deems to be fair (acting reasonably).
- d. These Terms are governed by the laws of Victoria, Australia.
- e. Members will be bound by their terms of membership with YMCA. To the extent of any inconsistency between the terms of membership and these Terms, these Terms will take priority.
