YMCA 'TWO-WEEKS FREE SWIM PROMOTION' - TERMS AND CONDITIONS (Terms)

1. OFFER AND ELIGIBILITY

- c. The Promotion is available at Boroondara Sports Complex (Participating Centres) between the dates of Wednesday 27 November 2024 to Tuesday 3 December 2024 (Promotion Period).
- d. To be eligible for the Promotion:

 - ii. you must become a swimming lesson member at that Participating Centre and commit to an eight-week minimum term set out by the Participating Centre within the Promotion Period.
