

YMCA 'Sunday Sessions Free Membership' - TERMS AND CONDITIONS (Terms)

1. OFFER AND ELIGIBILITY

- a. This 'Sunday Sessions Free Membership' promotion (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- b. By participating in the Promotion, you agree to be bound by these Terms.
- c. The Promotion is available at Boroondara Sports Complex, Ashburton Pool and Recreation Centre, and Hawthorn Aquatic and Leisure Centre (**Participating Centre**) between the dates of 9 August to 13 September 2026 (**Promotion Period**).
- d. To be eligible for the Promotion:
 1. You must not be a current member at any of the Participating Centres.
 2. Participants must take a card from a Participating Centre and collect all six stamps to go in the draw.
 3. Completed card must be returned to reception by 13 September.
- e. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

2. COMPETITION TERMS

- a. If you meet the criteria set out in clause 1(d), you will go in the draw to win a 12-month membership or one of three 3-month memberships for the Participating Centre of their choice.
- b. To qualify, you must be 18+ years old.
- c. The Promotion is only available at Participating Centres.
- d. You must complete six visits within the Promotion Period and return the completed card to reception on 13 September 2026 to go in the draw.
- e. Winners will be drawn and notified on Monday 21 September 2026.

- f. Lost cards cannot be replaced unless proof of booking into a session each week can be provided to reception team.
- g. Only one stamp is permitted to be collected per week, per person.
- h. Participants can only claim a stamp for a casual gym, casual swim or booked class visit.
- i. All other applicable fees and charges in respect of membership (new or existing) will be payable in accordance with the applicable membership terms. Your membership will otherwise be governed by such membership terms.
- j. Employees of YMCA and their immediate families are not eligible.
- k. Prizes are non-transferable and cannot be exchanged for cash or any other alternative.
- l. The prize credit will be applied to your account and taken off a future direct debit.

- b. By entering the competition, participants consent to the use of their name and results in promotional material, both in-centre and on digital platforms.
